August 18, 2016

The regular meeting of Fremont City Council was called to order at 7:30 p.m. in the form prescribed by the General Rules of Council. President Hafford called the meeting to order. The following members answered roll call: Zilch, Ruiz, Stout, Taylor, Otte, Koebel, and Knisely. The minutes for council meeting held on August 4th were approved.

Before the reading commenced, Councilman Otte invited John Damschroder to speak to council about the economic development and how to attract business and residents to the city. He suggested that our city slogan “Where People Come First” is authentic to any national search would find about our community. He suggested that we have an opportunity to not only be Fremont, Ohio but to be Fremont America.

Second reading of a resolution suspending Sections 941.03 (D) and (I) prohibition of alcohol in a Public Park subject to the State Permit Regulations; from September 9, 2016 thru September 11, 2016 for the purpose of a Charity Fundraiser solely at Rodger Young Park in honor of former Fremont employee Mike Piero and declaring an emergency. Mr. John Frazier, David and Patrick Piero addressed the council with a plea to pass the resolution pertaining to the Mike Piero Memorial Foundation Fundraiser. On motion to suspend Rule 4 by Mr. Koebel and seconded by Mr. Taylor. Motion failed 5 yes votes to 2 no votes.

First reading of a resolution authorizing the approval and issuance of a warrant for payment of \$3,169.53 to Foster Auto Body Inc., and declaring an emergency. On motion to suspend Rule 4 by Mr. Koebel and seconded by Mrs. Ruiz. Motion carried 7 yeas votes. On motion to adopt by Mr. Knisely and seconded by Mr. Taylor. Motion carried 7 yeas votes. (Res. 2016-1986)

Council showed no objection to the liquor license stock transfer that was presented concerning Walgreens gas station.
