

ORDINANCE NO. 2014- 3681

**AN ORDINANCE AUTHORIZING THE SAFETY SERVICE DIRECTOR TO ADVERTISE FOR BIDS FOR THE PURCHASE OF EQUIPMENT, CONSTRUCTION PROJECTS, STREET AND BRIDGE MATERIALS AND REPAIRS, AND YEARLY SUPPLIES AND SERVICES, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:**

**SECTION 1.** That the Safety Service Director is hereby authorized to advertise for bids for the hereinafter named equipment, construction projects, street and bridge materials and repairs, and yearly supplies:


- 2014 Street Improvements
- Storm Sewer Improvement and Extension Projects
- Sewer Collection Improvement and Extension Projects
- Street Striping and Marking
- 2014 CDBG Middle Street Waterline Project
- Yearly Water and Sewer Maintenance Supplies (2015)
- Yearly Street Maintenance Supplies (2015)
- Yearly Water and Sewer Chemical Supplies (2015)
- Traffic Signal Improvements
- Water Distribution Improvement and Extension Projects
- WTP Lagoon Cleaning
- Dam Project
- Long Term Control Construction
- Land Application of Sewage Sludge
- Heavy Construction Equipment

- Building Demolition Services
- Police HVAC Improvement

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

**SECTION 3.** The immediate operation of the provisions of this ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being said emergency being the need for the City of Fremont to advertise and receive bids in a timely manner.

This ordinance, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this ordinance shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.




