

RESOLUTION 2014 - 1933 —

**A RESOLUTION BY THE FREMONT CITY COUNCIL ENDORSING
AND SUPPORTING PASSAGE OF THE SANDUSKY COUNTY
MENTAL HEALTH LEVY AND DECLARING AN EMERGENCY**

WHEREAS, Fremont City Council recognizes the need for quality mental health and recovery services which will benefit all sectors of Sandusky County's population, including children, families, seniors, public safety personnel, and veterans; and

WHEREAS, Fremont City Council recognizes the financial benefit to the community by properly funding these services; and

WHEREAS, it is much more cost-effective to provide treatment through a properly funded mental health and recovery services board than through the legal system; and

WHEREAS, Fremont City Council recognizes this levy will substantially improve the overall quality of life for all residents of Sandusky County while costing the average homeowner about two dollars and twenty five cents (\$2.25) per month or approximately \$28.00 dollars a year;


**NOW, THEREFORE, BE IT RESOLVED BY THE FREMONT CITY COUNCIL
OF THE CITY OF FREMONT, STATE OF OHIO:**

SECTION 1. City Council does hereby endorse and support passage of the Sandusky County Mental Health Levy as the levy will provide critical services for law enforcement and public safety personnel, a safer environment and more opportunities for our families and children, improved quality of life for our senior citizens and vital treatment and assistance for those that deserve it most, our soldiers and veterans.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. The immediate operation of the provisions of this resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need for Fremont City Council to endorse passage prior to the May 6th primary election.




