

ORDINANCE NO. 2015 - 3761

AN ORDINANCE AUTHORIZING FUND TRANSFERS IN THE AMOUNT OF \$11,574,676.00 FOR FISCAL YEAR 2015 FOR THE CITY OF FREMONT, STATE OF OHIO AND DECLARING AN EMERGENCY.

THE FREMONT CITY COUNCIL OF FREMONT, STATE OF OHIO, DOES ORDAIN AS FOLLOWS:


SECTION 1. Fremont City Council hereby authorizes the transfers for fiscal year 2015 as listed below:

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

**SECTION 3.** The immediate operation of the provisions of this ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need to authorize the Auditor to draw warrants for payments of contracts and expenses for City of Fremont for fiscal year 2015 from January 1, through December 31, 2015.






