

ORDINANCE NO. 2015 - 3193

AN ORDINANCE REVISING SEWER RATES BEGINNING JANUARY 1, 2016 AND DECLARING AN EMERGENCY.

WHEREAS, the rates for the use of City sewers are set forth in Section 921.03 of the Codified Ordinances; and

WHEREAS, Ordinance No. 2010-3517 set the rates for all bills for sewer service rendered on or after January 1, 2014 and also included an additional monthly fee for the construction of improvements to the Water Pollution Control Center (WPCC); and

WHEREAS, Ordinance No. 2011-3560 modified the monthly fee for the construction of improvements to the WPCC that was set in Ordinance No. 2010-3517; and

WHEREAS, Ordinance No. 2013-3676 stated that the effective administration of the WPCC improvement project and the maintenance and improvement of the collection system does not require an increase in the 2013 rates for sewer service for all bills rendered on or after January 1, 2014;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FREMONT, OHIO:

SECTION 1. That the sewer rates set forth in Chapter 921 of the Codified Ordinances for the City of Fremont shall be revised per the schedule attached hereto and incorporated herein. Said revision shall be effective as per the schedule beginning on January 1, 2016. (Attached as Exhibit "A")

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. The immediate operation of the provisions of this ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need to have the revised rates in effect on January 1, 2016 for the proper administration of the City wastewater collection and treatment system.

This ordinance, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this ordinance shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.






