A RESOLUTION AUTHORIZING THE MAYOR TO FILE AN APPLICATION FOR SUBMISSION TO THE OHIO DEVELOPMENT SERVICES AGENCY FOR FISCAL YEAR 2016 COMMUNITY DEVELOPMENT BLOCK GRANT (" CDBG ") PROGRAM AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio has funds available through the Community Development Block Grant ("CDBG") Program for dissemination to eligible cities and counties, and

WHEREAS, the Ohio Development Services Agency is accepting applications from cities and counties to access funds, and

WHEREAS, the Ohio Development Services Agency has determined the City of Fremont is eligible for funds in the amount of \$75,000 for CDBG eligible activities, and

WHEREAS, two public hearings are required to be held to receive public input for the application prior to submission. The first public hearing was held March 1, 2016 at 11:00 a.m. and the second public hearing is scheduled for June 6, 2016 at 10:00 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:

SECTION 1. The Mayor is hereby authorized to submit a grant application to the Ohio Development Services Agency for fiscal year 2016 Allocation CDBG Program.

SECTION 2. Upon award, \$35,000 will be allocated to ADA Doors/Public Rehabilitation; \$16,800 to ADA Pedestrian Signals/Street Improvements; \$11,200 to Community Work Program Public Services; and \$12,000 to Fair Housing and Administration.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 4. The immediate operation of the provisions of this resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need to file an application with the Ohio Development Services Agency by the deadline June 17, 2016.

This resolution, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this resolution shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.


