

RESOLUTION NO. 2017-2012

A RESOLUTION SUSPENDING SECTIONS 941.03(D) AND (I) PROHIBITION OF ALCOHOL IN A PUBLIC PARK SUBJECT TO THE STATE PERMIT REGULATIONS FROM JULY 15TH, THRU JULY 16TH, 2017 FOR THE PURPOSE OF A CHARITY FUNDRAISER SOLELY AT RODGER YOUNG PARK IN HONOR OF FORMER FREMONT EMPLOYEE MIKE PIERO AND DECLARING AN EMERGENCY.

WHEREAS, there is a request for alcohol to be sold and served at a charity fundraiser from July 15th, thru July 16th, 2017 at Rodger Young Park in honor of former Fremont Employee Mike Piero; and

WHEREAS, City Council hereby recognizes the dedication, commitment, and contributions Mike Piero made to the youth, Recreation Center, Special Olympians, and entire Fremont community; and

WHEREAS Mike Piero's life truly exemplified the City's motto, "Where People Come First" therefore, it is in the best interest of the City to suspend the rule in his honor.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:

SECTION 1. City Council hereby suspends Section 941.03(D) and (I) Prohibition of alcohol in a public park subject to the State Permit Regulations from July 15th, thru July 16th, 2017 for the purpose of a charity fundraiser solely at Rodger Young Park in honor of former Fremont employee Mike Piero.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. The immediate operation of the provisions of this resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need to obtain the liquor license in an expeditious manner.

This resolution, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this resolution shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.




