

ORDINANCE NO. 2013- 3679

AN ORDINANCE TO AUTHORIZE THE EXPENDITURE AND DIRECT THE SAFETY SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH ANY DOMESTIC WORK, INC. DBA ADW, INC. IN AN AMOUNT NOT TO EXCEED \$64,121.50; FOR CLEANING SERVICES, OF \$54,420.00, FOR CARPET CLEANING OF \$3,506.00 AND FOR FLOOR STRIPPING AND REFINISHING OF \$6,195.50 AT FREMONT CITY FACILITIES, FOR THE PERIOD JANUARY 1, 2014 THROUGH DECEMBER 31, 2014 AND DECLARING AN EMERGENCY.


BE IT ORDAINED BY THE COUNCIL, CITY OF FREMONT, STATE OF OHIO:

SECTION 1. The Fremont City Council hereby authorizes the expenditure and directs the Safety Service Director to enter into a contract with Any Domestic Work, Inc. dba ADW, Inc. in an amount not to exceed \$54,420.00 for cleaning services, \$3,506.00 for carpet cleaning, and \$6,195.50 for floor stripping and refinishing for Custodial Services at Fremont City Facilities, for the period January 1, 2014 through December 31, 2014.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 3. The immediate operation of the provisions of this ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont, said emergency being that the current cleaning contract ends on December 31, 2013 and, therefore, the City will have a cleaning contract in effect beginning January 1, 2014.

This ordinance, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this ordinance shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.






