
AN ORDINANCE REPEALING ORDINANCE NO. 98-3062 WHICH AUTHORIZED A RESERVE BALANCE FUND FOR THE PAYMENT OF CLAIMS FOR WORKERS' COMPENSATION FUNDING FOR SAID RESERVE BALANCE ACCOUNTS TO COME FROM REFUNDS OF PREVIOUS WORKERS' COMPENSATION PAYMENTS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:

**SECTION 1.** On August 20, 1998 Fremont City Council passed Ordinance No. 98-3062 which authorized a Reserve Balance Account be established from refunds received for previous Workers' Compensation payments which were paid into the Workers' Compensation Fund.

**SECTION 2.** The State Auditor has determined that a change to R.C. 5705.13 (A)(3) makes this Ordinance unnecessary and should be removed from the City's Code.


**SECTION 3.** This Ordinance shall take effect and be in force from and after its passage and publication according to law.



ORDINANCE NO. 98- 3062

**AN ORDINANCE ESTABLISHING A RESERVE BALANCE ACCOUNT FOR THE PAYMENT OF CLAIMS FOR WORKERS' COMPENSATION FUNDING FOR SAID RESERVE BALANCE ACCOUNTS TO COME FROM REFUNDS OF PREVIOUS WORKERS' COMPENSATION PAYMENTS AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:**

**SECTION 1.** That a Reserve Balance Account be established from refunds received for previous workers' compensation payments which were paid into the Workers' Compensation Fund.

**SECTION 2.** This Ordinance is hereby declared to be an emergency measure necessary for the preservation of health, safety and welfare of the citizens of Fremont. Said emergency being the immediate need to establish a Reserve Balance Fund for refund monies from the Workers' Compensation Fund.
