

ORDINANCE NO. 2012- 3606

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PART OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF FREMONT, OHIO, AND TO AMEND OR ENACT SECTIONS OF THE TRAFFIC, GENERAL OFFENSES AND FIRE PREVENTION CODES TO CONFORM TO ENACTMENTS OF THE GENERAL ASSEMBLY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Fremont, Ohio; and

WHEREAS, numerous sections of the Traffic, General Offenses and Fire Prevention Codes need to be updated so as to conform to enactments of the General Assembly.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:

SECTION 1. That the editing, arrangement and numbering or renumbering of those ordinances and parts of ordinances incorporated in the 2012 Replacement Pages are hereby approved as parts of the various component codes of the Codified Ordinances of Fremont, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances.



SECTION 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.




