

RESOLUTION NO. 2012- 1870

AUTHORIZING A TRANSFER AND APPROPRIATION OF FUNDS FROM THE REVOLVING LOAN FUND (RLF) TO THE GENERAL FUND IN THE AMOUNT OF \$20,000.00 TO BE USED FOR ECONOMIC DEVELOPMENT THROUGH THE BIG FREMONT PLAN, AND DECLARING AN EMERGENCY

WHEREAS, the State of Ohio Department of Development, Office of Community Development has given a waiver (attached as Exhibit A) to the City of Fremont for utilization of RLF funds in the amount of \$20,000.00 for its BIG Fremont Plan;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:


SECTION 1. The City Council hereby authorizes the transfer of funds totaling \$20,000.00 as listed below:

SECTION 2. That the \$20,000 transferred to the General Fund from the Revolving Loan Fund be appropriated for Economic Development for the BIG Fremont Plan.

SECTION 3. The immediate operation of the provisions of this resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need for the BIG Fremont plan to begin expeditiously.

This resolution, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this resolution shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.
