Journal of Council May 17, 2018

The regular meeting of Fremont City Council was called to order at 7:30 p.m. in the form prescribed by the General Rules of Council. President Hafford called the meeting to order. The following members answered roll call: Liebold, Knisely, Smith, Zilch, Ruiz and Otte. Councilman Slick was absent. The agenda for tonight and the minutes for May 3rd were approved.

Before the regular meeting agenda....Mayor Sanchez along with Captain Conger, Officer Kennedy, and Sargent Kingsborough, president of the local FOP, who presented Officer Josiah Britner with the Life Saving Award for his amazing job of helping a civilian in a situation on April 22nd. His dedication and kindness may have saved the gentleman's life.

First reading of a resolution authorizing the approval and issuance of a warrant for payment of \$10,159.72 to Southeastern Equipment Co., Inc., and declaring and emergency. First reading of a resolution authorizing the approval and issuance of a warrant for payment of \$4,496.40 to the Spyglass Group, LLC, and declaring an emergency. First reading of an ordinance authorizing the Safety Service Director to submit a written agreement to participate in the Ohio Department of Transportation's annual winter road salt contract (18-19) in accordance with Revised Code Section 5513.01(B) and declaring an emergency. On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Liebold. Motion carried 6 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mr. Zilch. Motion carried 6 yea votes. First reading of an ordinance authorizing the execution of an agreement between Scott and Marsha Williams and the City providing for a Tax Abatement of 75% for real property over a period of ten years to promote job expansion within the city and declaring an emergency. Mr. Gross explained that council was informed about this project at the last council meeting. Proper paperwork has been filed and approved by both schools and the county. He was asking for a rule 4 so the project can begin in a timely fashion. On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Zilch. Motion carried 6 yea votes. Community Partnership Committee - Chairman Knisely announced on June 7th Superintendent Jon Detwiler and Dave Perrin will be here to give an update of the past school year.

Parks and Recreation Committee – Mr. Smith encourage everyone to fill out the Rec. Department survey that is located online. He also encouraged everyone to use the facilities this summer.

Laws, Rules, and Ordinance Committee – Chairman Zilch nothing to report.

Executive Director of Downtown Fremont - Kristie Bilger updated everyone about the Fishing and Outdoor Festival this Saturday from 10 a.m. to 4 p.m. She passed out schedule beginning June 16th with a car show. October 5th and 6th there will be a Crop Circle Festival.
