Journal of Council November 1, 2018

The regular meeting of Fremont City Council was called to order at 7:30 p.m. in the form prescribed by the General Rules of Council. President Hafford called the meeting to order. The following members answered roll call: Zilch, Otte, Sleek, Smith, Ruiz, Knisely, and Liebold. The minutes were approved from the October 18th meeting.

Second reading of an ordinance authorizing Fund Transfers in the amount of \$2,700,000.00 for the City of Fremont, State of Ohio.

Second reading of an ordinance amending appropriations within General Fund 101 and Income Tax Fund 201.

Second reading of a resolution authorizing the approval and issuance of a warrant for payment for payment of \$3,051.57 to Clemans, Nelson & Associates, Inc. and declaring an emergency. On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Knisely. Motion carried 7 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 7 yea votes. Second reading of a resolution authorizing the approval and issuance of a warrant for payment of \$7,167.00 to Aqua-Line and declaring an emergency. Second reading of an ordinance accepting the application for annexation for the parcel being part of the Northwest quarter of Fractional Section 2, Town 5 North-Range 15 East, Ballville Township, Sandusky County, State of Ohio containing .301 acres, more or less, already approved by the Board of Sandusky County Commissioners in Resolution 2018-191, adopting the recommendation of the Assistant Engineer for interim zoning of the area to be B-2 General Commercial District, and adjusting the boundary lines of Ballville Township for exclusion of the territory that is part and parcel of this annexation. Second reading of an ordinance petitioning the Board of Sandusky County Commissioners to adjust the boundary lines of Sandusky Township so as to exclude the territory that, as a result of annexation, now lies within the corporate boundaries of the City of Fremont (submitted by University Housing Solutions annexation of 15.009+/- acres – Ordinance No. 2018-3895). On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Sleek. Motion carried 7 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mr. Otte. Motion carried 7 yea votes. Ord. 2018-3928

First reading of an ordinance amending appropriations within General Fund 101, and declaring an emergency. On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Knisely. Motion carried 6 yea votes to 1 no vote. On a motion to adopt by Mrs. Ruiz and seconded by Mr. Zilch. Motion carried 7 yea votes. Ord. 2018-3929

First reading of an ordinance to authorize the expenditure and direct the Safety Service Director to enter into a contract with Telamon Construction, Inc. in an amount not to exceed \$92,550.00 for construction of the Rodger Young Park for the Restroom and Shelter Improvements through the 2018 CDBG Funds and declaring an emergency. Mr. Frost asked that the council consider suspending Rule 4. On a motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Knisely. Motion carried 7 yea votes. On a motion to adopt by Mrs. Ruiz and seconded by Mr. Smith. Motion carried 7 yea votes. Ord. 2018-3930
