

**ORDINANCE NO. 2021 - 4066**

**AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PART OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF FREMONT, OHIO AND TO AMEND OR ENACT SECTIONS OF THE GENERAL OFFENSES CODE TO CONFORM TO ENACTMENTS WITH THE GENERAL ASSEMBLY.**

**WHEREAS**, various ordinances of a general and permanent nature have passed which should be included in the Codified Ordinances of Fremont, Ohio; and

**WHEREAS**, sections of the General Offenses Code need to be updated so as to conform to enactments of the General Assembly.

**THE FREMONT CITY COUNCIL OF FREMONT, STATE OF OHIO, DOES ORDAIN AS FOLLOWS:**

**SECTION 1.** The editing, arrangement, and numbering or renumbering of those ordinances incorporated in the March 2021 Replacement Pages are hereby approved as parts of the various component codes of the Codified Ordinances of Fremont, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances.

**SECTION 2.** The following sections of the Traffic and General Offenses Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly:

Traffic Code

- 501.99 Penalties for Misdemeanors. (Amended)
- 529.07 Open Container Prohibited. (Amended)

**SECTION 3.** A copy of such ordinances or parts of ordinances as edited, arranged, numbered or renumbered as parts of the Codified Ordinances are attached to this Ordinance in the form of March 2021 Replacement Pages to the Codified Ordinances.

**SECTION 4.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.


**SECTION 5.** This ordinance shall take effect and be in force from and after its passage and publication after the earliest date according to law.
