

**RESOLUTION NO. 2022- 2134**

**A RESOLUTION DIRECTING THE BOARD OF ELECTIONS OF SANDUSKY COUNTY TO PLACE UPON THE BALLOT AT THE PRIMARY ELECTION TO BE HELD MAY 3<sup>RD</sup>, 2022 THE QUESTION OF APPROVING AN ORDINANCE TO AMEND SECTION 172.01(B)(2) OF THE CODIFIED ORDINANCES OF THE CITY OF FREMONT TO IMPOSE AN ADDITIONAL ONE-HALF OF ONE PERCENT (0.5%) INCOME TAX EFFECTIVE JANUARY 1<sup>ST</sup>, 2023 FOR A PERIOD OF FIVE (5) YEARS TO BE USED SOLELY FOR THE CONSTRUCTION, REPAIR, IMPROVEMENT, AND MAINTENANCE OF STREETS AND ROADWAYS INCLUDING RELATED DEBT CHARGES IN THE CITY AND APPURTENANCES THERETO AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FREMONT, STATE OF OHIO:**

**SECTION 1.** The Council hereby authorizes and directs the Board of Elections of Sandusky County to place upon the ballot at the primary election to be held May 3<sup>rd</sup>, 2022 the question of approving Ordinance No. 2022- 4096 attached hereto as Exhibit A and incorporated by reference herein, to impose an additional one-half of one percent (0.50%) income tax effective January 1<sup>st</sup>, 2023 for a period of five (5) years (until December 31<sup>st</sup>, 2027), to be used solely for the purpose of construction, repair, improvement, and maintenance of streets and roadways including related debt charges in the City of Fremont and appurtenances hereto.

**SECTION 2.** The proposed ordinance to be submitted to the electors of the City for their consideration shall be as set forth in Ordinance No. 2022- 4096.

**SECTION 3.** The form of the ballot to be used at the election on the question shall be as follows:

“Shall Ordinance No. 2022- 4096, providing for an additional one-half of one percent (0.50%) levy on income effective January 1<sup>st</sup>, 2023 for a period of five (5) years to be used solely for the purpose of construction, repair, improvement, and maintenance of streets and roadways including related debt charges in the City of Fremont and appurtenances thereto, be passed?”



**SECTION 4.** The Clerk of Council is hereby directed to file a certified copy of Ordinance No. 2022-4016, together with a certified copy of this Resolution with the Sandusky County Board of Elections at least ninety (90) days prior to the date of the election set forth in Section 1 hereof.

**SECTION 5.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

**SECTION 6.** The immediate operation of the provisions of this resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Fremont. Said emergency being the need to permit the ordinance to be submitted to the Sandusky County Board of Elections in a timely fashion to be placed on the May 3<sup>rd</sup>, 2022 ballot.

This resolution, provided it receives a two-thirds yea or nay vote of all the members elected to the Fremont City Council, is hereby declared to be an emergency measure and this resolution shall be in full force and effect from and after its passage by the Council of the City of Fremont, approval by the Mayor, and publication and posting as required by law.


